NORTHERN LIGHTS: NORTHERN LIGHTS: All week long, the Arctic Circle has been aglow with auroras. "The lights have been incredibly bright and active," says Øystein Lunde Ingvaldsen of Bø i Vesterålen, Norway. He took this picture on Feb. 17th:

"This has been a very nice month for auroras," agrees Wioleta Zarzycka of Iceland, where coastal waters have been turning green in reflection of the sky above.

The lights have even descended as far south as Scotland. "On Monday night, we had the first auroras I have seen here in years," reports Gordon Mackay of Campsie Fells.

AUSTIN - An angry, suicidal software engineer and part-time musician, apparently distraught over a decadeslone tax dispute, crashed his plane into IRS offices, killing one other person and seriously injuring two others.

The pilot, Andrew Joseph Joe" Stack III, 53, also had apparently set his Austin ouse on fire.

Stack was a failed business owner from California whose IRS wees appeared to have started there back in the 1980s. He had come to Austin about seven years ago for work.

In a rambling note he typed out and posted on his software company's Web site, Stack alluded to his own death.

"If you're reading this, you're no doubt asking yourself, 'Why did this have to happen?'" reads the note posted on Suzck's Web sire. www.embeddedart.com. "I am finally ready to stop this insanity, Well, Mr. Big Brother IRS man, let's try something different; take my pound of flesh and sleep well."

The IRS declined to comment on Stack's dispute.

"We can't comment on taxpayers due to disclosure laws," said Lea Crusberg, an IRS spokeswoman for the southern Texas region.

Stack took off in his singleengine Piper Cherokee from Georgetown Municipal Airport at 9:40 a.m. Twenty minutes later, his plane crashed into the IRS building in north Austin that houses the criminal investigations unit, sparking a fire and sending two people to the hospital.

Stack, who died in the crash, was identified as the

pilot who steered the plane into the IRS building.

The identity of the other person killed was not available but is believed to be an IRS employee who could not be accounted for earlier in the day.

### Obama to spell out new healthcare plan



By Donna Smith Donna Smith – 4 mins ago WASHINGTON (Reuters) – President Barack Obama is expected to publish his healthcare plan as early as Sunday or Monday, combining features of the two Democratic bills passed by the Senate and House of Representatives, congressional aides and healthcare advocates said on Friday.

The administration's bill will aim to jump-start the stalled healthcare overhaul and comes just days ahead of a planned televised White House summit with congressional Republicans, who are calling on Democrats to scrap the bills and start over with a far less sweeping proposal.

Democrats are struggling to push healthcare legislation over the finish line in the face of sagging public support and solid Republican opposition bolstered by recent election victories in Massachusetts, Virginia and New Jersey.

The legislation the White House will post on its website is expected to reflect common ground negotiated over the past several weeks by House and Senate Democratic leaders.

By DOUG FERGUSON, AP Golf Writer Doug Ferguson, Ap Golf Writer – 13 mins agoPONTE VEDRA BEACH, Fla. – Missing his smile and aura of invincibility, Tiger Woods finally showed his face to a waiting world Friday and apologized again for cheating on his wife, without revealing the scope of his infidelity or when he will return to golf.

Standing at a podium before a presidential-blue backdrop in a hushed room of his closest associates, Woods stumbled a few times as he read a 13 1/2-minute statement. He offered no new details of what happened or what's next, except that he was leaving Saturday for more therapy.

"I have made you question who I am and how I could have done the things I did," Woods said.

Woods' wife, Elin, did not attend his first public appearance since he crashed his car into a tree outside their home three months ago, setting off shocking allegations of rampant extramarital affairs.

#### Official: FBI probing Pa. school webcam spy case

The FBI will explore whether Lower Merion School District officials broke any federal wiretap or computer-intrusion laws, said the official, who spoke on condition of anonymity because the official was not authorized to discuss the investigation.

Days after a student filed suit over the practice, <u>Lower Merion officials</u> <u>acknowledged Friday that they remotely activated webcams 42 times in the past 14 months, but only to find missing student laptops</u>

They insist they never did so to spy on students, as the student's family claimed in the federal lawsuit.

#### US Marines seize Taliban headquarters, IDs, photos

MARJAH, Afghanistan – After a fierce gunfight, U.S. Marines seized a strongly defended compound Friday that appears to have been a Taliban headquarters — complete with photos of fighters posing with their weapons, dozens of Taliban-issued ID cards and graduation diplomas from a training camp in Pakistan.

Insurgents who had been using the field office just south of Marjah's town center abandoned it by the end of the day's fighting, as Marines converged on them from all sides, escalating operations to break resistance in this Taliban stronghold in southern Helmand province.

Marines from Lima Company, 3rd Battalion, 6th Marines fought their way south from the town center Friday after residents told them that several dozen insurgent fighters had regrouped in the area.

# ATF investigates Liberty County sheriff's captain in missing firearms case




The Bureau of Alcohol, Tobacco and Firearms is investigating a Liberty County Sheriff's Department captain in the disappearance of approximately 500 firearms, according to court documents.

The firearms disappeared when Cpt. Harry Kelley was the captain of the Cleveland Police Department, investigators said.

Kelley was in charge of the Cleveland Police Department's property room at the time.

About 100 of the missing guns were recovered at the Sportsman's Outlet in Humble, but the other 400 are still missing, according to an affidavit



#### Why the Fed Likes Independence



Last week it was revealed that when Treasury Secretary Tim Geithner was Chairman of the New York Federal Reserve, he urged AIG officials not to disclose to the Securities Exchange Commission relevant details of agreements with banks to bail out Goldman Sachs. Apparently he felt at the time that regulators and the public would be angry that taxpayer money was used to fully compensate bankers who made some horrifically bad investment decisions. These banks should have suffered the consequences of the huge risks they were taking. After all, they kept plenty of rewards when times were good. Instead, the Fed found a way to socialize these major losses so these banks could survive and continue making more bad decisions, at the expense of the American people and the value of the dollar.

Geithner claims that they had to take politically unpopular actions to save the economy from collapse. Half of that is right – it was politically unpopular, but it is extremely premature at best, to claim the economy has been saved. It was just reported that 85,000 more jobs in December. Unemployment stands at 10% officially, and 22% according to more traditional calculations. It is hard to argue that this sort of government waste has done anything but harm to our economy. Raiding Main Street to bail out Wall Street is a foolish idea. Main Street productivity and the strength of the dollar is the bedrock of the economy. You cannot gut this foundation without eventually toppling everything else. This is what too many policy makers either don't understand or refuse to face. Or even worse, perhaps they do understand, but don't care!

## Maybe we could learn from the Chinese

#### China executes rogue trader, millions still missing

BEIJING (Reuters) – China on Tuesday executed a former securities trader for embezzlement, the first person in the industry to be put to death, but millions of yuan are still missing, a state newspaper said.

Yang Yanming was sentenced to death in late 2005 and took the secret of the whereabouts of 65 million yuan (\$9.52 million) of the misappropriated funds to his grave, the Beijing Evening News said.

The report added that Yang was the first person working in China's securities sector to be executed.

"Preserve your moral integrity and don't set too much store by business results," Yang told the newspaper before the sentence was carried out.

He was the general manager of the Beijing securities trading department of the China Great Wall Trust and Investment Corp., which became Galaxy Securities, from 1997 to 2003.

Conscious that the growing gap between rich and poor could generate resentment, China is battling corruption and stock trading abuses. It has used the death penalty as a deterrent in serious cases.


The Rev. Marcus McFaul, senior pastor at Highland Park Baptist Church in Austin, said "the instruction of religious faith, discipleship and a life of service — one shaped by devotion and piety — is the responsibility of each faith community, whether church, synagogue or mosque. It is the responsibility of parents and parishes, not public schools."

Board member David Bradley, R-Beaumont, a leader of the board's seven social conservative members, said he respected the Baptist theologians "but I listen to my own pastor."

Bradley said he's certain "there will be efforts (by board members making amendments) to preserve, protect and strengthen America's godly heritage."



CHIP BERLET: Well, if you just say, "Look, they're all crazy, they're all nuts, we don't have to pay any attention to them, and they're not real," that does several things. One is that it obscures this dynamic that's occurring that Lenny Zeskind explained so well, that there's a struggle going on in these right-wing movements right now, and white supremacist organizers are trying to pull the tea bag movement way towards more aggression and a more ideological position.

But also, I talked to organizers who said when they try and reach out to white communities, where they have in the past had some traction around issues like immigration or issues like racism or even organizing around the political economy and the environment, that they're getting doors slammed in their face, because, you know, people can hear the Democrats and—I'm sorry, but the Keith Olbermanns and the Rachel Maddows making fun of their neighbors and them, and they don't want to hear from progressive organizers.



CHIP BERLET: Well, I think that if you're looking at it in terms of a society, people need to stand up and say this is way out of control, that whenever you have this kind of anger and demonization and scapegoating, it's very toxic to democracy. And I wrote a report called "Toxic to Democracy" to explain how that works.

The other thing is that Democrats really have to stop this snide and smug and arrogant, you know, "haha, let's laugh at the rednecks and rubes" stance, because, you know, first of all, the political right has out-organized centrist Democrats repeatedly since 1980. So I have no idea why they're laughing on the Democratic Party side. And the other thing these inside-the-Beltway spin doctors who say, you know, "It's OK to call them the radical religious right, the political extremists, they're crazy"—you know, this whole theory that came out of the '50s and '60s that these people are psychologically maladjusted has been repudiated in social science. So, you know, there are people being pulled into the right-wing populist and white supremacist movement that skillful, progressive organizers and labor organizers could be bringing into a multi-racial, multi-ethnic coalition.



Many victims contracted it in 2008, after having been screwed for the past two years. Naturalists and epidemiologists are amazed at how destructive this disease has become since it is easily cured -- by **voting out all incumbents!**"



## **Shay's Rebellion**

1786 to 1787 (Wikipedia)

An armed uprising in central and western Massachusetts (mainly Springfield) from 1786 to 1787. The rebellion is named after Daniel Shays, a veteran of the American Revolution who led the rebels, known as "Shaysites" or "Regulators". Most of Shays's compatriots were poor farmers angered by crushing debt and taxes. Failure to repay such debts often resulted in imprisonment in debtor's prisons or the claiming of property by the government.

Seeking debt relief through the issuance of paper <u>currency</u> and lower taxes, they attempted to prevent the courts from seizing property from indebted farmers by forcing the closure of courts in western Massachusetts.

## The financial situation leading to the rebellion

The financial situation leading to the rebellion included the problem that European war investors (among others) demanded payment in <u>gold and silver</u>; there was not enough specie in the states, including Massachusetts, to pay the debts; and through the state, wealthy urban businessmen were trying to squeeze whatever assets they could get out of rural smallholders. Since the smallholders did not have the gold that the creditors demanded, everything they had was confiscated, including their houses.

At a meeting convened by aggrieved commoners, a farmer, Plough Jogger, encapsulated the situation:

"I have been greatly abused, have been obliged to do more than my part in the war; been loaded with class rates, town rates, province rates, Continental rates and all rates...been pulled and hauled by sheriffs, constables and collectors, and had my cattle sold for less than they were worth...The great men are going to get all we have and I think it is time for us to rise and put a stop to it, and have no more courts, nor sheriffs, nor collectors nor lawyers."It was decided that the legislature (General Court) in Boston would be petitioned.

## The financial situation leading to the rebellion-2

Veterans of the Continental Army like General Charles Logan Harding, also aggrieved because they had been conscripted, had to fight with no payment to help them pay for their living, and because they were treated poorly upon discharge, including being locked up in debtors' prison, began to organize their neighbors, the besieged farmers, into squads and companies in order to halt the confiscations. 8 Veteran Luke Day of West Springfield, Massachusetts asked the judges holding the confiscatory hearings to adjourn until the Massachusetts legislature met. Throughout Massachusetts, newly organized farmers and veterans faced militia at courthouse thresholds. But sometimes the farmers and veterans were the militia, and often the majority of the militias sided with the veterans and farmers.

## Henry Gale, a co-leader

In Princeton he lived in comparative independence. And being a man of good education, he occupied a high social position, and after the close of the Revolution, he joined heartily in the discussions of the day: how an independent but bankrupt state might be galvanized into life and a circulating medium in the shape of money established. But while these subjects were racking the brains of the wise and good patriots of the country, the amnesty proclamation had restored Boston and other large towns to wealthy loyalists, who had left the state with the British army when they evacuated Boston.

These wealthy men, having lost all sympathy for the rebel country and people on their return, commenced indiscriminately prosecution for the collection of their old claims, most of which had been outstanding during the war. This alarmed the otherwise quiet creditors, and particularly as "Greenbacks" as a legal tender did not then exist and any debtor to the amount of \$5 could be ordered to jail. So great was the rush of business to the courts that 2000 cases were said to have been entered at one term of the court at Worcester, Massachusetts.

## Henry Gale, a co-leader

The people in alarm held public meetings and petitioned the legislature for relief. The legislature setting in Boston under the influence of Boston merchants and Boston lawyers, who were also reaping a great harvest in high fees, refused the desired relief under the plea that they had no power, a plea generally reported too when there is a lack of disposition.

The people then petitioned the courts that they adjourned over without granting the judgments, until some kind of relief could be afforded by the legislature, but the courts declared they would not be instructed in their duty by the people, while Judge Artemas Ward, in a speech of two hours long from the steps of the Court House in Worcester declared to the people that their "conduct was treason and the punishment of treason was death."

Thus the people of Worcester and other interior counties were for two years ground between two millstones, the courts and the jails, with nothing but bankruptcy and imprisonment staring them in the face. To soldiers who had so lately vindicated their rights by their swords and had learned for seven years to treat the word "traitor" as a byword, it was no hard affair to fly to arms, not to overthrow their government but simply to temporarily stop the courts in granting judgments in civil causes.

## The Whiskey Rebellion

1791 - 1794

less commonly known as the Whiskey Insurrection, was a popular uprising that had its beginnings in 1791 and culminated in an insurrection in 1794 in Pittsburgh, Pennsylvania, in the Monongahela Valley. During George Washington's presidency, the government decided to tax whiskey in order to pay off the national debt. This infuriated the citizens and led to the Whiskey Rebellion.






Today's stock market bears about as much resemblance to the real economy as a game of poker or Monopoly or Trivial Pursuit.




## Rasptuin or Pachauri





Grigory Rasputin, the "devil monk", is the most mysterious figure in the Romanov tragedy. Born a poor Siberian peasant, Rasputin became Alexandra's closest advisor due to his ability to alieve her son's sufferings. A powerful and a alcoholic, Rasputin attended orgies and church services with equal devotion. The police and family friends warned the royal couple about Rasputin. The Tsar did nothing, Alexandra dismissed the tales and their tellers as lies and liars.
